CRITERIA FOR PROVISIONAL ADMISSION TO CLASS XI FOR THE ACADEMIC SESSION 2024-2025 (INTERNAL CANDIDATES ONLY)

- i. **Provisional Admission will be confirmed to Science Stream** on merit basis considering marks obtained in ICSE 2024 (Mathematics & Science) for internal students. Provisional admission may be granted on the marks of Selection & Orientation Examination on merit basis. (Subject to availability of seats). Merit Criterion will be decided by the Principal.
- ii. Provisional Admission will be confirmed to Commerce Stream: Preference of Mathematics will be solely done on merit basis considering the marks obtained in Mathematics in ICSE 2024 and Provisional admission may be granted on the marks of Selection & Orientation Examination on merit basis. (Subject to availability of seats). Merit Criterion will be decided by the Principal.
- Provisional Admission will be confirmed to Humanities Stream: Preference will be solely done on merit basis considering the marks obtained in Mathematics in ICSE 2024 and Provisional admission may be granted on the marks of Selection & Orientation Examination on merit basis. (Subject to availability of seats). Merit Criterion will be decided by the Principal.
- iv. **Confirmed admission** is subject to the candidate passing the ICSE Examination in March 2024 with a Pass Certificate from Council for the Indian School Certificate Examinations, New Delhi, having Hindi / Bengali as one of their Pass subjects.
